TRUST DEED

THIS DEED OF TRUST is made on this 5th day of September, 2018 between Mrs.P.Moushmi D/o.Pandurangan Hindu, aged about 29 years, residing at No.10/20, Nathamuni Street, Shenoy Nagar ,Chennai -600 030, Tamilnadu , hereinafter called the FOUNDER of the one part:

AND

1. Mr.RAJIV KRISHNA, son of Mr.B.Ramachandran, Hindu, aged about 31 years, residing at No.3, 42nd Street, 6th Avenue, Ashok Nagar, Chennai – 600 083. (Cont...2)

2. Mr.B.Ramachandran, S/o.A.V. Balakrishnan, Hindu, aged about 57 Years, residing at No.AS3B, 42nd Street, 6th Avenue, Ashok Nagar, Chennai – 600 083 hereinafter called Trustees of the OTHER PART.

WHEREAS the Founder of the Trust had a keen and earnest desire to help and serve the people belonging to socially and educationally backward classes in general, irrespective of caste, creed and religion and for that purpose he is desirous of creating a public charitable trust.

WHEREAS the Founder has set apart a sum of Rs.5,000/- (Rupees Five thousand only) in favour of the Trust to form the corpus fund of the said Trust.

WHEREAS the trustees have also agreed to accept the Trust and carry out the objects of the Trust herein created on the terms and conditions hereinafter mentioned.

NOW THIS TRUST DEED WITNESSETH AS FOLLOWS:

1. The name of the Trust shall be “RAJIV KRISHNA FOUNDATION” and the office of the Trust shall be at No.3, 42nd Street, 6th Avenue, Ashok Nagar, Chennai – 600 083.
2. The objects of the Trust are:
 - a) To establish, maintain and administer educational institutions, imparting school education, general education, technical education, medical education, nursing courses, Dental courses, catering institute and other higher education.
 - b) To organize specialized teaching in different branches of arts, Science, Medicine and Technology, give instructions in specialized courses in the aforesaid and allied subjects that may be instituted in any of the Universities in India.

- c) To undertake publication of research studies, magazines, periodicals etc. produced by the institutions established by the Trust.
- d) To hold refresher course, short courses, seminars, conferences and the like on current, social and socio-economic problems and on social, economic, cultural and educational activity for the benefit of persons engaged in social work and/or in the teaching of the subjects relating hereto.
- e) To cultivate in the staff and students of the institution a sense of social, scientific and technical awareness and cultural conscience.
- f) To organize special coaching and training to poor children and/or provide for free distribution of books, study materials, educational appliances.
- g) To give assistance in the form of books, scholarships, stipend etc. to poor and/or meritorious students and grant and provide for such other financial assistance to the needy as may be considered appropriate.
- h) To give financial assistance or medical relief to the poor and the needy people in distress.
- i) To establish, maintain and administer clinics and/or hospitals by employing Doctors and other staff to run the same.
- j) To carry out scientific research in the field of medicine, engineering, agriculture, economics, management studies, computer science and other fields.
- k) The benefits of the objects of the trust shall reach all persons irrespective of caste, creed or religion.

- 1) To do all such other acts and things as may be necessary and conducive to the attainment of the above objectives.

DECLARATION OF THE TRUST

The Founder doth hereby transfers a sum of Rs.5,000/- (Rupees Five thousand only) in favour of the Managing Trustee to hold the said fund and the other properties that may be endowed, donated, granted, gifted, acquired or purchased, into the use of Trustees, upon Trust for the use and benefit of the Trust.

THE BOARD OF TRUSTEES

- i) The board of Trustees shall consist of not more than 12 members. The Founder shall be one of the members constituting the Board.
- ii) The following would be the 1st set of trustees:
 - 1) Mrs.P.Moushmi Founder and Trustee
 - 2) Mr.Rajiv Krishna Managing Trustee
 - 3) Mr.B.Ramachandran Trustee

The first set of Trustees shall hold office for life. The vacancy caused in the board of trustees by the resignation or otherwise shall be filled by nomination by Mrs.P.Moushmi, Founder Trustee and/or by Managing Trustee.

- iii) The Board of trustees may increase the number of trustees up to 12(including the life trustees).
- iv) The life time trustees may appoint further life time trustees during their life time subject to the maximum number of trustees permitted by the trustee deed by amending the trust deed with the approval of the Commissioner of Income Tax (Exemptions).

: 5 :

- v) After the life time of the Founder/Life Trustee the said vacancy may be filled by nomination by the remaining trustees and such person will hold office for a period of 2 years like the other trustees and would possess the same powers and duties of the other Trustees.
- vi) If any Trustee becomes bankrupt or is found guilty by a court for an offence involving moral turpitude or remains absent from India for a continuous period of 6 months or resigns his/her post or becomes incapacitated mentally or physically to discharge his/her duties, the remaining Trustees shall nominate a substitute for the remainder terms of such Trustee.
- vii) The Trustees who retire are eligible for reappointment or re-nomination.
- viii) Mr.A.R.RAJIV KRISHNA shall be the Managing Trustee of the Board of Trustees for life time.
- ix) The Trustees may resign their office by a letter in writing addressed to the Managing Trustee who shall be the competent authority to accept the same.

POWERS AND DUTIES OF THE BOARD TRUSTEES:

- i) The Trustees may accept gifts, donations and endowment for the purpose of purchasing or acquiring immovable properties or such other purposes in fulfillment of the objects of the trust.
- ii) The Trustees may acquire moveable and immoveable properties and put up buildings in the same for the purpose of the Trust.
- iii) The Trustees are empowered to take on lease properties for the purpose of the Trust.
- iv) The Trustees may appoint such of its staffs they think necessary for the purpose of the Trust, and their conditions of service shall be such as may from time to time be laid down by the Board of Trustees.

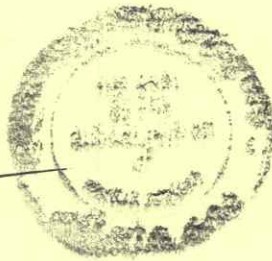

- v) The Trustees may invest the properties and monies of the Trust in such manner as they think fit, to the best advantage of the Trust and in accordance with the provisions of section 13(1)(d) read with section 11(5) of the Income tax Act, 1961.
- vi) The Trustees shall meet at least once in 3 months or as often as necessary and proceedings shall be recorded regularly in the minutes book to be maintained for the purpose.
- vii) In the event of there being a difference of opinion between the Trustees, the decision of the majority of the Trustees present and voting shall be binding and effective and shall be carried out. In case of tie or equality of votes the Managing Trustee shall have a 'Casting Vote' in addition to his normal voting power.
- viii) It shall be open to the Trustees to take decisions by circulation.
- ix) The Trustees may open and operate current or other accounts with any bank or banks. The Bank account shall be operated by the Managing Trustee Mr.A.R.RAJIV KRISHNA. After the Life time of the Managing Trustee, the said account shall be operated jointly by 2 Trustees as may be determined by the Board.
- x) The Board may extend the sphere of activities of the Trust or undertake any activity in furtherance of the main objects of the Trust by passing resolution and with the approval of the Commissioner of Income Tax(Exemptions).
- xi) The Trustees may from time to time set apart as and by way of sinking or Reserve fund the whole or any part of the surplus income produced by the trust fund in any particular year and may invest any such sum or sums so set apart and the resulting income thereof in the manner aforesaid with power at any time to vary any such investment or investments.

- xii) The Trustee or Trustees may at any time sell any investment or investments representing the capital or income of the sinking fund and apply the proceeds thereof or the capital or income of the sinking fund as if the same were income produced by the Trust Fund.
- xiii) Proper books of accounts shall be maintained by the Trust and shall be audited by a Chartered Accountant once in a year, which shall be conclusive of the matters stated in the report.
- xiv) The Board of Trustees shall have all necessary powers to do such other lawful things as are necessary and incidental for the Board in effectively carrying out the administration and management of the Trust.
- xv) The funds and Income of the Trust shall be solely utilized towards the objects of the trust and no portion of it shall be utilized for payment to Trustees by way of profit, interest, dividend or other forms.
- xvi) The Trustees shall maintain the minutes book in which the proceedings of all meetings of the Trustees shall be recorded by the Trustees and the same shall be signed by the Chairman of the Meeting which shall be conclusive of the matters stated therein.
- xvii) The Trustees may frame rules and regulations as to the duties and responsibilities of each Trustee, and providing for any other matters connected with the administration of the Trust and its Management.
- xviii) The trust by passing appropriate Resolutions in the board of trustees authorize Managing Trustee or all trustees to raise loan or loans with bank or banks or financial institutions and to execute all necessary loan documents and offer the trust properties as security for the advances or loans availed and the trustees to stand as securities in their personal capacities. The amount borrowed shall be fully utilized for the purpose of the trust.

- xix) The trusts authorize managing Trustee or all trustees by passing appropriate Resolutions in the board of trustees to give grants, gifts, donations, and corpus and endowment funds to any other trust having similar objects and having registration under section 12A and 80G Exemption from Income Tax Department.
- xx) Any amendment to the clauses of the Trust deed will be carried out only by the approval of the board of trustees and the Commissioner of Income tax.

CUSTODY OF DOCUMENT

The Managing Trustee or his nominee shall have the custody of all the documents, deeds of title relating to the Trust properties and investment, and the books of account and other records relating to the Trust and shall be responsible for safe custody and preservation of the same.

ADVISORY BODY

The Trustees may maintain a set of advisors for purpose of utilizing their services in the Trust on such other and conditions as the Board of Trustee may from time to time determine.

IRREVOCABILITY

It is declared that the Trust is irrevocable. If the Trust fails for any reason, the net assets of the Trust both moveable and immovable shall be handed over to any other Trust having same objects as declared by the majority of the Trustees.

In respect of all the other matters not specific provided herein the provisions of Indian Trust Act 1882 shall apply the Trust.

GENERAL

- i) In case of winding up/dissolution, the net funds and other properties shall be transferred to institutions having similar objects and enjoying Exemption under section 11 and section 80 G of the Income Tax Act, 1961.
- ii) The activities would be confined to the territory of India.
- iii) The activities would be of purely charitable nature not motivated for profit.
- iv) The benefit of objects would be available to the general public irrespective of caste, creed, religion or sex.
- v) The funds of the institution would be invested as per section 11(5) of the Income Tax Act, 1961.
- vi) The funds of the Institution would not be applied for any religious purposes or given to religious Institutions.
- vii) Alienation of immovable property shall be done with prior approval of the Commissioner of Income Tax (Exemption).
- viii) At the time of registration no movable and immovable property in this trust
