The savings, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation and contingency funds may be further utilized for promoting the school.
- That the school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body organization.
- 8. That the school will not open classes under CBSE pattern particularly class IX /X /XI/ XII and will not use CBSE name in any manner without obtaining affiliation.
- 9. That the Principal and Correspondent / Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circular issued by the board from time to time. The school under takes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
- 10. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc., with respect to the school and staff of the school.
